On this date the community arrived on time during the court sessions which is being held in Malindi land courts, but Kaloleni community opted to stream live here in Kaloleni social hall so that the community would be able to know how is the case going on and the outcome, given that it was a ruling date. The court cases started at 9;00am but St. Lukes land case involving community members and ACK diocese of Mombasa led by Bishop Baya was mentioned at 10;30am the ACK lawyer Mugambi was asked if she responded on the submissions from the community lawyer Mr. Mang'aro but she replied that she has not yet responded until now since the last two months.

She was asked why until now she has not responded.? She complained of not being served yet, but the judge acknowledge that she must have been serve because all the documents are there, another thing she `was asked if she have an email address, but nothing to say so far in front of the court. The judge told the Mr. Mangaro the community lawyer that the court has received the other two submissions which he served county government and national land commission.

After that the judge gave another date on 5th match hearing on the responses on side of the county government and national land commission to respond on the same and also Ruling to be done.
