INTRODUCTION

We, the representatives of Kakuyuni Ward Social Accountability Forum an affiliate of Citizen Participatory Development Group (Kilifi Citizen Forum) a Community Based Organization working within Kilifi County, do hereby file this petition to the County Executive Committee Member, Education, ICT and E-Government, County Government of Kilifi, for the interest of the entire community of Kakuyuni villages, Kakuyuni sublocation, Goshi location, Kakuyuni ward, Malindi sub-county in Kilifi County. Our organization thus; Citizen Participatory Development Group is registered under the State Department for Gender and Social Development and operates in Kilifi County. The organization is a local Community Based Organizations (CBOs) that builds the capacity of the community for active citizen participation in decision making, prudent engagement and resource management aimed at promoting Gender Responsive Public service delivery.

DESCRIPTION OF THE PROJECT IN QUESTION:

The Kakuyuni Early Childhood Development Education (ECDE) Centre classroom and administration construction project was initiated by the community and proposed for funding to the county government of Kilifi more than ten years ago. The project aimed at providing an enable, safe and health environment to the early childhood development school going population of Kakuyuni Village in Goshi location. The county government of Kilifi allocated some funds to support the implementation of the classroom and administration construction project but it was not completed as per the community proposal.

For the last ten years, the two classroom and administration block education facility has not been used by the early childhood development school going population because it is not fitted without

doors, chairs and tables, blackboard, widows, and floor making the learning environment uncomfortable and unsafe for the children. Due to the incompleteness of the two classrooms and administration block education facility is being misused by the surrounding community as a public toilet. The community feel that this wastage of taxpayers' money. This has resulted to the Kakuyuni ECDE school population dropping by children from the centre being transferred to other centre since the class being used is very old and congested.

The other issue is that the Kakuyuni ECDE school toilet contracted in the 2024/2025 Financial Year is a direct pit latrine and are not supplied with water posing danger and threat to the health and lives of the children.

Therefore, our HUMBLE PETITIONERS PRAY to the County Government of Kilifi Department of Education, ICT and E-Government urgently;

1. That the department should take an action to complete and equip the two classrooms and administration block project so as to improve the learning environment of the children
2. That the department should improve the situation of the pit latrine to Morden toilet so as to be sure of the children safety
3. That the Kakuyuni community shall get a response of their prayers from the Kilifi County Department of Education, ICT and E-Government urgently; within seven (7) days from the day this petition is submitted.
